CODE AND TERMS OF CONDUCT

- 1) At all times abide by the referees decision
- 2) At all times play the game in a fair manner
- 3) At all times abide by marshals or committee persons directives at games, either as a player or spectator
- 4) On no occasion is the club to be brought into disrepute, either on or off the field by a registered player, or player's guardian
- 5) Any registered player or players guardian asked by the executive committee to attend a hearing, must be given 7 days notice. The executive on hearing of evidence, have the right to either:
 - a) Warn
 - b) Suspend
 - c) De-register

The decision of the executive committee is final.

- 6) All players and players' guardians must assist with the running of **your** canteen and hanging and pulling down of soccer nets, as directed by team coach, manager or committee member.
- 7) Each team must provide from within their team
 - a) A coach
 - b) A Manager
 - c) A Team Representative.
- 8) One parent or legal guardian must be present at all times, on game day and training sessions. A parent or guardian of an unsupervised player will be phoned to come and collect **their** child.
- 9) I understand that if the club incurs any fines caused wholly or in part, by anyone's behaviour and/or conduct on or off the field of play, as a player, official or parent of a junior player of this club, I will reimburse the Club for any such fine it incurs. I understand that I will remain suspended from all soccer related activities until such time as the fine/s are paid.
- 10) You have no objection to the listed player's image being recorded either by photo, film or video. In doing so, you give permission for your club, association or state body to reproduce or use the image in promotional literature, websites and/or film and TV. Names of minors will not be displayed against their images without prior consent of their parent/s and/or guardians.
- 11) For players playing in U9 and above age groups, you may be subject to grading selections. Please check our guidelines at the time of registration, as all grading decisions rest with the management committee and are not subject to appeal. Players who transfer or deregister will be charged a **\$13.60** N.D.S.F.A administration fee on their departure. A player cannot de-register once they have taken the field for a competition game.

DECLARATION BY A PLAYER, COACH, MANAGER OR OFFICIAL

- a. Player(s) have not registered for any other soccer team, club or Association this year (Applies to Players only. Coach, Manager, Official excluded). If this statement is not correct, I understand that the player must suspend their application for membership to the above club until such time as the player(s) have demonstrated their de-registration and clearance from team/club/association by providing written proof of the player(s) transfer/clearance/de-registration.
- b. The player(s) are not under suspension by any Soccer Club or Association.
- c. The player(s) are duly qualified to play for this team according to the rules of the Nepean District Soccer Football Association Inc. and the player(s) agree to abide by the rules and decisions of the N.D.S.F.A. Inc, including the Code of Conduct.
- d. There are no moneys or property owing by any of the player(s) to any Club or Sporting Association.
- e. I understand that by making a false declaration on the registration form and being found guilty of same, that the player(s) may face suspension and/or expulsion from all Soccer activities, expose my club to monetary penalties and my team to loss of points.***
